Protecting your personal information is a priority for us. WHAT WE COLLECT

We get information about you in a range of ways.

Information You Give Us. SHARING OF PERSONAL INFORMATION

We may share personal information as follows:

- 1. We may share personal information with your consent. For example, you may let us share personal information with others for their own marketing uses. Those uses will be subject to their privacy policies.
- 2. We may share personal information when we do a business deal, or negotiate a business deal, involving the sale or transfer of all or a part of our business or assets. These deals can include any merger, financing, acquisition, or bankruptcy transaction or proceeding.
- 3. We may share personal information for legal, protection, and safety purposes.
 - a. We may share information to comply with federal or state laws.
 - b. We may share information to respond to lawful requests and legal processes.
 - c. We may share information to protect the rights and property of AdamColvinRealEstate.com, our agents, customers, and others. This includes enforcing our agreements, policies, and terms of use.
 - d. We may share information in an emergency. This includes protecting the safety of our employees and agents, our customers, or any person.
